# **Directors' remuneration voting trends**

**June 2017** 

# The purpose of this report is to provide an analysis of voting trends for directors' remuneration from the 2016 AGM season and the 2017 AGM season to date.

The 2014 reporting season saw the introduction of a new disclosure and voting regime for directors' remuneration for quoted companies, requiring companies to seek a binding vote from shareholders on their directors' remuneration policy every three years and an annual advisory vote on the directors' remuneration report. Companies that have not sought changes to their remuneration policy since 2014 will be required to propose a resolution to renew approval of the policy at their 2017 AGM.

Where voting has been conducted at the AGM on a show of hands, analysis of the voting results data in this report includes the proxy votes submitted to the company prior to the AGM.

#### Comparison of voting results for 2016 and 2017

Based on the information contained in Thomson Reuters Practical Law's *What's Market, AGMs: FTSE 350*, this section of the report looks at the voting trends of those FTSE 350<sup>1</sup> companies that:

- have held their 2017 AGM on or before 31 May 2017; and
- proposed a resolution to approve the remuneration policy and/or the remuneration report at their 2016 AGM

(172 companies (59 FTSE 100 and 113 FTSE 250))2.

#### **Remuneration report**

Of the 172 FTSE 350 companies reviewed:

#### Average percentage of votes cast

• Each company proposed a resolution to approve the remuneration report. The average percentage of votes received in favour of the remuneration report during 2016 was 92.62% compared to 92.78% so far this year (see graph 1).

#### Substantial votes against<sup>3</sup>

- 34 FTSE 350 companies (20%) received a substantial vote against the resolution to approve the remuneration report at their 2016 AGM. This compares to 33 companies (19%) at their AGMs held in 2017 (see graphs 2 and 3).
- Of the 34 companies that received a substantial vote against the remuneration report in 2016, 28 companies have received an increase in the number of votes cast in favour of the resolution at their 2017 AGM, although seven of these companies still received a substantial vote against the resolution.
- 13 companies have received a substantial vote against the remuneration report resolution in both 2016 and 2017 (see graph 4). It is interesting to note that of these 13 companies, six have received an increase in the number of votes cast against the resolution at their 2017 AGM.

#### **Failed resolutions**

- Three companies (Smith & Nephew plc, Paysafe Group plc and BP p.l.c.) received insufficient votes in favour of the remuneration report resolution for it to be passed at their 2016 AGM (see graph 2). Each of these companies received more than 95% of the votes cast in favour of the resolution at their 2017 AGM.
- Two companies (Pearson plc and Crest Nicholson Holdings plc) have received insufficient votes in favour of the remuneration report for it to be passed at their 2017 AGM having received 90.19% and 99.27% respectively of the votes cast in favour of the resolution in 2016 (see graph 3).

#### **Remuneration policy**

Of the 172 FTSE 350 companies reviewed:

 27 companies proposed a resolution to approve the remuneration policy at their 2016 AGM compared to 108 companies so far this year.

#### Average percentage of votes cast

 The average percentage of votes received in favour of the remuneration policy during 2016 was 89.75% compared to 93.92% so far this year.

#### Substantial votes against

- Of the 27 companies that proposed a resolution to approve the remuneration policy at their 2016 AGM, seven companies (26%) received a substantial vote against the resolution (see graph 5).
- Of the 108 companies that proposed a resolution to approve the remuneration policy at their 2017 AGM, 17 companies (16%) have received a substantial vote against their remuneration policy this year (see graph 6).
- Whilst the voting results indicate that proportionally fewer companies have received substantial votes against the policy this year, no direct comparison can be made with 2016 as the

- number of companies seeking the triannual vote this year is substantially higher.
- All resolutions proposed this year have received sufficient votes for the resolution to be passed (see graph 6).

#### **Failed resolutions**

 Of the 27 companies that proposed a resolution to approve the remuneration policy at their 2016 AGM, only one company (The Weir Group PLC) received insufficient votes cast in favour of the resolution for the policy to be approved (see graph 5). This company received 94.65% votes in favour of the resolution at its 2017 AGM.

#### **Voting results for 2017**

Based on the information contained in Thomson Reuters Practical Law's *What's Market, AGMs: FTSE 350*, this section of the report looks at the voting trends of those FTSE 350 companies that have held their 2017 AGM on or before 31 May 2017 (186 companies (59 FTSE 100 and 127 FTSE 250<sup>4</sup>))

#### **Remuneration report**

Of the 186 FTSE 350 companies reviewed:

- Each company proposed a resolution to approve the remuneration report.
- Of these 186 companies, 34 companies (18%) received a substantial vote against the resolution and two companies (Pearson plc and Crest Nicholson Holdings plc) received insufficient votes cast in favour of the resolution for it to be passed.
- The average percentage of votes received in favour of remuneration report resolution so far this year is 93.11%.

#### **Remuneration policy**

Of the 186 FTSE 350 companies reviewed:

- 119 companies (64%) have proposed a resolution to approve the policy this year.
- Of these companies, 17 companies (14%) received a substantial vote against the resolution. All resolutions have been approved.
- The average percentage of votes received in favour of the policy resolution so far this year is 94.22%.
- Three companies have withdrawn the resolution to approve the remuneration policy from the resolutions to be proposed at their 2017 AGM to allow more time to engage with shareholders.
- 105 companies have followed the three year approval cycle in relation to their remuneration policies and proposed a resolution to renew their policies at their 2017 AGM having previously sought approval of a new policy at their 2014 AGM.

#### Substantial votes against election or re-election of directors

Of the 186 FTSE 350 companies reviewed:

#### Substantial votes against and failed resolutions

- 36 companies (19%) received a substantial vote against a resolution to approve the election or re-election of one or more of their directors, numbering 66 directors in total.
- Of these 36 companies, one company (Centamin plc) also received insufficient votes in favour of the resolution to approve the re-election of one director for it to be passed.
- Of the one or more directors of the 36 companies that
  received a substantial vote against a resolution to approve
  such election or re-election, ten directors are the chair of
  the remuneration committee of their respective companies.
  The director of the company that received insufficient votes
  in favour of the resolution to approve his re-election was a
  member of the remuneration committee.

#### Statements in company announcements in relation to the reelection of remuneration committee chairs

- Two companies noted in the announcement of their AGM voting results that the substantial votes cast against resolutions to approve the election or re-election of the relevant directors related to their re-election as remuneration committee chair and two companies noted shareholder concern in respect of some aspect of directors' remuneration.
- Centamin plc stated in the announcement of its AGM voting results that it believed that the reasons that insufficient votes were cast in favour of one director's re-election resulted from the director's appointment to the remuneration committee and the consequent non-compliance with the UK Corporate Governance Code by reason of his non-independence.
- Whilst the companies mentioned above have included an indication as to why shareholders have voted against the election or re-election of their directors, many companies do not disclose this information. As a result, it is not possible to analyse whether the votes cast by shareholders against the election or re-election of such directors were related to their chairmanship of the remuneration committee.

### **Voting trends**


The following graphs are based on the 172 FTSE 350 companies that:

For the purposes of these graphs, a substantial vote against includes a vote of 50% or more against a resolution.





Number of FTSE 350 companies that received a substantial vote against their remuneration report in 2016





### Votes against remuneration report of the 13 FTSE 350 companies that received a substantial vote against the resolution in 2016 and 2017




