## Draft Finance Bill 2014: Abolition of stamp duty and stamp duty reserve tax on growth market shares

## Introduction

We are the Quoted Companies Alliance, the independent membership organisation that champions the interests of small to mid-size quoted companies. Their individual market capitalisations tend to be below £500m.

The Quoted Companies Alliance is a founder member of European**Issuers**, which represents over 9,000 quoted companies in fourteen European countries.

The Quoted Companies Alliance Tax Expert Group has examined your proposals and advised on this response. A list of members of the Expert Group is at Appendix A.

## Response

We fully support the Government's action to abolish stamp duty on growth market shares as of 28 April 2014. We believe that this measure will increase liquidity and investment in small, growing companies.

We have reviewed the draft finance bill clauses in this area and have no comments on it. However, we have received feedback from our members that it is not very clear in the accompanying Q&A about what the process is for exchanges in terms of applying for the exemption and what the approval process is – especially if a market applies after the initial recognition period has finished. It may be worth clarifying this for market participants in future Q&A documents.
