1. Welcome to Hasmukh Dodia, Yvonne Batista and Olakunle Ogundele, HMRC, to discuss the new employment related securities (ERS) online service

FB welcomed HD, YB and OO and everyone introduced themselves.

HD thanked the QCA for the opportunity to come speak to the Share Schemes Expert Group. He explained that their presentation is a practical demonstration of how the website and the new online system for registering employment related securities work. He added that the system is simple but there can be mistakes, which they bring to the Group's attention during the presentation.

YB reminded the Group that all schemes must be registered online by 6 July 2015. However, registering the schemes could take two weeks while the request for the unique registration number is being processed; therefore, she advises companies to register well in advance. She mentioned that it normally takes 3-5 days. She stressed that if companies do not register their schemes on time, tax advantages will be lost and companies will not be entitled to tax relief; furthermore, a penalty will apply as of 7 July 2015.

YB and OO gave an overview of how registering schemes and arrangements for Employment Related Securities will work with the new online system, namely regarding CSOP, EMI, SAYE, SIP as well as other schemes and arrangements. YB highlighted that employers must register all existing and any new share schemes and arrangements online with HMRC and that companies should ensure that they have access to HMRC online services.

HD agreed to circulate this presentation to the group.
